- Define the business context and the boundaries of applicability of the Environmental Management System
- Comply with legal requirements and company procedures regarding environmental protection and energy consumption
- Evaluate and monitor all environmental aspects / impacts generated by the performance of company processes by defining the environmental and energy indicators to be constantly monitored
- Identify and monitor the areas / processes that use energy
- Adopt the best technologies aimed at reducing pollution and energy needs
- Constantly monitor the use of water by promoting the use of technologies aimed at reducing consumption, adopting constant controls to safeguard the resource and prevent its pollution
- Responsibly manage the chemicals used in business processes by assessing the risks, ensuring control, proper management and promoting the use of substances with less dangerous properties
- Optimize the use of raw materials, resources and energy deriving from non-renewable sources.
- Maintain the efficiency of the systems to minimize pollution and energy needs
- Increase the use of energy from renewable sources
- Involve the whole organization, each with their own role and skills, spreading within the company, through constant training and information, an environmental culture aimed at achieving correct behavior in terms of environmental protection and waste reduction
